RESOLUTION CONFORMING, APPROVING AND ADOPTING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2006-001 "RESOLUTION RECOMMENDING APPROVAL OF THE PRIORITIZED SOCIO-ECONOMIC DEVELOPMENT PROJECTS FROM THE CY 2006 20% INTERNATIONAL REVENUE ALLOTMENT (IRA) FUND OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Development Council of the Municipality of Tigbauan, held a meeting on January 3, 2006 at 2:15 in the afternoon at the Tigbauan Covered Court to discuss the 20% Development Fund for the CY 2006. After thorough deliberation and review of the prioritized projects, the Municipal Development Council unanimously approved the allocation of the 20% IRA Fund of the local government unit of Tigbauan for the year 2006 with a total amount of P7,813,412.00. the itemized projects and programs are enumerated in the attached Excerpt and Resolution of the Municipal Development Council, hereto attached as Annex "A"

WHEREAS, the review of the foregoing Resolution of the Municipal Development Council embodying the 20% Development Projects for the year 2006, shows apparent compliance with Section 287 of the Local government Code, Rule XXXVI, Srt. 454 (d) of its Implementing Rules and Regulations and executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1,2 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, it is worthwhile to note that the amount of P600,000.00) under item No. 1.6 (a) Other Program of Project of Similar Nature-Repair, maintenance of various projects of similar in nature (water system, repair & maintenance of Day Care Center, etc.) is for the project allocation of the Sangguniang Bayan members, Vice Mayor, ABC President and SKMF President. The amount for the Vice Mayor's Allocation is P80,000.00 and P52,000.00 each for every Sangguniang Bayan member, ABC President and SKMF President. This item was discussed during the said MDC Meeting and the same was noted and well taken, hence it was put into record;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the 20% development funds shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 434 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 Joint Memorandum Circular No. 1,2 of 2005 of the DILG issued on September 30, 2005;

WHEREAS, compliance with all existing law, rules, and regulations shall be the sole responsibility of the officials of the implementing local government units;

NOW, THEREFORE, on motion of HON. SUZETTE ALQUISAD, Chairman, Committee on Appropriation, Budget, Finance, Accounts and Legal matters and duly seconded unanimously,

RESOLVED, to conform, approve and adopt Municipal Development Council Resolution No. 2006-001, "Resolution Recommending Approval of the Prioritized Socio-Economic Development Projects from the CY 2006 20% International Revenue Allotment (IRA) Fund of the Municipality of Tigbauan, Province of Iloilo",
