FOR THE CONCRETING OF PNE-KILOMETER SUPA ROAD, MUNICIAPLITY OF TIGBAUAN, PROVINCE OF  
ILOILO

WHEREAS, the Barangay Supa Road, a farm-to-market road, stretches from Barangay Buyuan to  
Barangay Supa;

WHEREAS, the said road is considered as the route of agricultural products, and other industries  
produced by the farmers situated in the area, and marketed in the Municipalities of Tigbauan, Guimbal,

the government suffers much of the losses hence the delivery of basic services to the said community is  
greatly hampered/affected;
