RESOLUTION NOT TO CONCUR WITH NOR CONFIRM THE APPOINTMENT OF MR. ARNEL T. TUMESA AS MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (MUNICIPAL ACCOUNTANT), LGU-TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, on February 19, 2006, this Hon. Sangguniang Bayan received a letter from the Municipal Mayor requesting for the concurrence and confirmation of the appointment of Mr. Arnel T. Tumesa as Municipal Government Department Head I (Municipal Accountant), LGU-Tigbauan who will assume office on March 1, 2006;

WHEREAS, on February 20, 2006, during the regular session of this Sanggunian, Mrs. Luz C. Tronco, the HRMO and Mr. Arnel T. Tumesa and Mrs. Maricar Socorro Tabang-Taleon, both applicants, were all invited to shed light on the process/methodology and criteria of selecting from among the candidates-applicants for this position, and to inform/enlighten the members of this Hon. Sanggunian as to the qualities and qualifications, personality, potentials and capabilities best suited for the said position;

WHEREAS, this Sangguniang has discovered that there were irregularities in the selection process as conducted by the Selection Board of this LGU, due to the fact that one candidate was given the highest possible rating in performance with hardly no experience at all in government auditing/accounting, while the other candidate for this position was given <u>zero</u> performance although this candidate has seventeen (17) years experience in this line of work in government service and has earned the respect of her peers while serving as Accountant in a Government Agency up to the present;

WHEREAS, another irregularity as discovered by the Sanggunian during the SB interview of Mrs. Luz C. Tronco, HRMO,, was her innocent remark, duly recorded, that ". . . she (Mrs. Maricar Socorro Tabang-Taleon, one of the candidates) had not met the Mayor earlier. . ." which we SB Members are inclined to understand that "meeting the Mayor earlier" is a condition precedent, and because the "*halo-effect*" had rendered the selection process fatally defective, and therefore its objectively was defeated;

WHEREAS, criteria for rating each candidate are not clear and objective, and the exhaustive publication as required for the vacant position was vaguely justified;;

WHEREAS, the Municipal Budget for CY 2006 had not yet been signed and approved by the Mayor, and this Budget shall only be after the approval by the Mayor of said Municipal Budget for CY 2006;

NOW, THEREFORE, upon motion by HON. ROMEO T. LEDESMA, of the SB Committee on Good Government, Public Ethics, Accountability and Civil Service and duly seconded unanimously, Be It

RESOLVED, as we hereby resolve, not to concur with nor confirm the appointment of Mr. Arnel T. Tumesa as Municipal Government Department Head I (Municipal Accountant), LGU-Tigbauan, Province of Iloilo,
