RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-02-06-184 OF MARLENE T. LIAO ET-AL  
WITH TCT NO. T-162,300 LOT NO. 1-A WITH AN AREA OF 612 SQUARE METERS MORE OR LESS,  
CONTAINING THREE (3) LOTS LOCATED AT TALDELORE ST., POBLACION, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. Sa-02-06-184 located at Taldelore St., Poblacion,  
Tigbauan, Iloilo and its supporting documents of MARLENE T. LIAO ET-AL was submitted to the Office of  
the Evaluating Officer, Tigbauan, Iloilo on February 14, 2006 for evaluation;

WHEREAS, after evaluation the said Subdivision Application and its supporting documents were  
forwarded to the Office of the Sangguniang Bayan last February 14, 2006 by the Evaluating Officer for  
authorization and approval;

WHEREAS, the said application TCT No. T-162-300 with Three (3) lots has a total land area of  
612 square meters more or less;

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;

WHEREAS, the conditions of said approval shall be the following;

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its  
entirely and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;

- b.) Comply with all the corrections as indicated on the plan;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt from securing registration and license to sell from HLURB.

NOW , THEREFORE, upon motion of Hon. Orvillo T. Tangente, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Romeo T. Ledesma, Hon. Alfonsito Estoce, and Hon. Pedro Rapadas,

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVE, to approve the Subdivision Application No. SA-02-06-184 of Marlene T. Liao Et-Al with TCT No. T-162,300 Lot No. !-A with an area of 612 square meters more or less containing three (3) lots located at Taldelore St., Poblacion, Tigbauan, Iloilo,

RESOLVED, FURTHER to forward copies of this resolution to the Office of the Municipal Mayor, Tigbauan, Iloilo for her information and appropriate action, Land Management Sector, DENR, Region VI, Iloilo City for their verification and approval of its filed survey returns and to the HLURB, Iloilo City to support said application for registration of the subdivision.
