RESOLUTION APPROVING THE SUBDIVISION APPLICATION NO. SA-02-06-186 OF RENEE L. VALENCIA
WITH TCT NO. TD-2158 LOT NO. 78-B WITH AN AREA OF 160 SQUARE METERS MORE OR LESS,
CONTAINING TWO (2) LOTS LOCATED AT TUPAS ST., POBLACION, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. SA-02-06-186 located at Tupas St., Poblacion,
Tigbuan, Iloilo and its supporting documents of RENEE T. VALENCIA was submitted to the Office of the
Evaluation Officer, Tigbauan, Iloilo on February 20, 2006 for evaluation;

WHEREAS, after evaluation, the said Subdivision Application and its supporting documents were
forwarded to the Office of the Sanggunang Bayan last February 23, 2006 by the Evaluating Officer for
authorization and approval;

WHEREAS, the said application, TCT No. TD-2158 with Two (2) lots has a total land area of 160
square meters more or less;

WHEREAS, the purpose/intent of this application is to sell;

- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient
cause for the cancellation of this approval and/or legal action;

- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt from securing registration and license to sell from HLURB.

NOW, THEREFORE, upon motion of Hon. Orvillo T. Tangente, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Romeo Ledesma and Hon. Alfonso Babiera,
