*WHEREAS, the Subdivision Application No. SA-02-06-185 located at Tupas – Terunez Sts. Poblacion, Tigbauan, Iloilo and its supporting documents of RENEE L. VALENCIA was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on February 20, 2006 for evaluation;*

- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.*

Valencia with TCT No. T-56984 Lot No. 79 with an area of 847 square meters more or less, containing Two (2) lots located at Tupas-Terunez Sts. Poblacion, Tigbauan, Iloilo,*
