**Resolution No. 2007-001**

RESOLUTION REMINDING ALL OFFICIALS AND EMPLOYEES OF THIS LOCAL GOVERNMENT UNIT (LGU) TO OBSERVE AND EXERCISE PROPER COURTESY AND DECORUM IN THEIR OFFICIAL RELATIONSHIP AMONG THEMSELVES AND WITH THE PUBLIC WHOM THEY SERVE, AS WELL AS TO RESPECT THE RIGHTS OF SUBORDINATES WHILE THE LATTER ARE PERFORMING THEIR OFFICIAL ASSIGNMENTS OR FUNCTIONS

WHEREAS, this Sangguniang Bayan was called to attention by a letter-Complaint, copy furnished this August Body, filed by a Utility Personnel against a Nurse II, both of whom are employees in the health department (Rural Health Unit) of LGU-Tigbauan;

WHEREAS, this Letter-Complaint is about **PHYSICAL INJURIES** perpetrated by this Nurse II against this Utility Personnel, as reported and properly entered in the Police Blotter of the Tigbauan PNP;

WHEREAS, this incident involves allegedly the arrogance of power or the so-called “**waslik poder**” which, if committed and demonstrated often enough, will allegedly classify the perpetrators as “notoriously undesirable employees” within that category as defined by the Civil Service;

WHEREAS, concerned citizens in our community are one in saying that these alleged acts of arrogance can only be committed by allegedly pseudo-professionals, because these acts have done violence to the code of conduct, professionalism, ethics, respect and courtesy, as prescribed and emphasized by the Civil Service, for all public officials and employees, in all related laws, CSC Rules, Regulations, and Memoranda-Circulars;

WHEREAS, Section 4 (c) – (Norms of Conduct of Public Officials and Employees) of RA 6713, specifically provides that public officials and employees **“... shall at all times respect the rights of others, and shall refrain from doing acts contrary to law...”**;

WHEREAS, although this case had been settled amicably, however, this Sangguniang Bayan hereby respectfully recommends and requests, that the Office of the Honorable Mayor, through the HRMO IV, shall please caution all employees in this LGU, especially those closely identified with the Mayor, NOT to repeat similar acts in the future, **OTHERWISE**, if repeated again and again, this Sanggunian shall be constrained to initiate and act accordingly, in order to restore the respect and trust of the public and taxpayers to the duly constituted authorities of this LGU, for good governance;

NOW, THEREFORE, upon Motion by HON. ROMEO T. LEDESMA of the Committee on Good Government, Public Ethics, Accountability, and Civil Service, and duly seconded by Hon. Suzette Alquisada, Hon. Roel Jarina and Hon. Jose Donel Trasporto, Be It

RESOLVED, as we do hereby resolve to remind all Officials and Employees of this Local Government Unit (LGU) to observe and exercise proper courtesy and decorum in their official relationship among themselves and with the public whom they serve, as well as to respect the rights of subordinates while the latter are performing their official assignments or functions;
