RESOLUTION CONFORMING AND APPROVING THE ANNUAL BUDGETS AND  
BARANGAY DEVELOPMENT PLANS FOR CY 2007 OF BARANGAYS: NAMOCON,  
BUYU-AN, PARARA NORTE AND ISAUAN, MUNICIPALITY OF TIGBAUAN,  
PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on January 29, 2007 endorsed to this Office the Annual Budgets and 20% Development Plan for CY 2007 of Barangays: Namocon, Buyu-an, Parara Norte and Isauan, this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinances embodying the 20% Development Projects and Annual Budgets for the year 2007 of Barangays: Namocon, Buyu-an, Parara Norte and Isauan shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1,2 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the 20% development fund shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 Joint Memorandum Circular No. 1,2 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government units;
