RESOLUTION CONFORMING AND APPROVING THE ANNUAL BUDGETS AND BARANGAY DEVELOPMENT PLANS FOR CY 2007 OF BARANGAYS: #1 (POBLACION), PARARA SUR, DAPDAP, NAPNAPAN SUR, CANABUAN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on February 19, 2007 endorsed to this Office the Annual Budgets and 20% Development Plans for CY 2007 of Barangays: #1 (Poblacion), Parara Sur, Dapdap, Napnapan Sur, Canabuan, this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinances embodying the 20% Development Projects and Annual Budgets for the year 2007 of Barangays: #1 (Poblacion), Parara Sur, Dapdap, Napnapan Sur, Canabuan shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, 2 of 2005 of the DILG and DBM issued on September 30, 2005;
