RESOLUTION CONFORMING AND APPROVING THE SUPPLEMENTAL BUDGET 2007-01 OF BARANGAY BUENAVISTA, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on April 23, 2007 endorsed to this Office the Supplemental Budget 2007-01 of Barangay Buenavista, this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinances embodying the Supplemental Budget 2007-01 of Barangay Buenavista shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, 2 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the 20% development fund shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;
