**Resolution No. 2007-025**

RESOLUTION APPROVING THE APPLICATION FOR SUBDIVISION APPROVAL NO. SA-04-07-202 OF RENATO CASTILLO WITH TCT NO. F-40581 LOT NO. 3175 WITH AN AREA OF 4,359 SQUARE METERS MORE OR LESS, CONTAINING SIX (6) LOTS LOCATED AT BRGY. PARARA NORTE, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. SA-04-07-202 located at Brgy. Parara Norte, Tigbauan, Iloilo and its supporting documents of RENATO CASTILLO was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on April 16, 2007 for evaluation;

WHEREAS, after evaluation, the said Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last April 16, 2007 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, TCT No. F-40581 Lot No. 3175 with six (6) lots has a total land area of 4,359 square meters more or less;

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;

WHEREAS, the conditions of said approval shall be the following:

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plan;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;

- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.

NOW, THEREFORE, upon motion of Hon. Orville T. Tangente, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Romeo Ledesma;

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVE, to approve the Subdivision Application No. SA-04-07-202 Of RENATO CASTILLO With TCT No. F-40581 Lot No. 3175 With An Area Of 4,359 Square Meters More Or Less, Containing Six (6) Lots Located At Brgy. Parara Norte, Tigbauan, Iloilo,
