RESOLUTION FAVORABLY ENDORSING BARANGAY BARROC RESOLUTION NO. 004-07 ENTITLED "RESOLUTION INTERPOSING NO OBJECTION ON THE APPLICATION OF SMART COMMUNICATION TO ESTABLISH AND OPERATE CELL SITE ANTENNA AT BRGY. BARROC, TIGBAUAN, ILOILO"

WHEREAS, the application for the construction of 120-ft. guyed tower cell site by SMART Communication, Inc. at Lot No. 579 owned by Lazaro Toroy located in Brgy. Barroc, Tigbauan, Iloilo (with pertinent documents) was indorsed by Mr. Jimmy Tupas, Evaluating Officer, LGU-Tigbauan, to the Office of the Sangguniang Bayan for authorization and approval;

WHEREAS, on June 4, 2007 SB session, the matter was referred to the Committee on Transportation, Communication and Energy for study and recommendation;

WHEREAS, the aforesaid committee rendered its Committee Report during the SB session on June 25, 2007 and the same was adopted by the August Body;

WHEREAS, for having complied and completed all the requirements set forth by the municipality (the barangay officials had conducted a series of public hearings with the barangay residents held sometime in April 4, 2007, April 11, 2007 and May 17, 2007 which was attended also by the following: Dr. Andres Dolar, Jr., Diplomate in Radiology and Ultrasound, a Medical Specialist II, Environmental Health Hospital Facilities Cluster who was invited by SMART Communication and the contractor who explained on the structural aspect of the project), hence this resolution. Furthermore, the cell tower will improve and boost the communication services offered by SMART which is not only beneficial to the people of Brgy. Barroc but also to the whole populace of this municipality as well as other neighboring municipalities.
