RESOLUTION CONFORMING AND APPROVING THE ANNUAL BUDGET AND BARANGAY DEVELOPMENT PLAN FOR CY 2007 OF BARANGAY BARROC, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on June 18, 2007 endorsed to this Office the Annual Budget and 20% Development Plan for CY 2007 of Barangay Barroc, this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinances embodying the 20% Development Project and Annual Budget for the year 2007 of Barangay Barroc shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, 2 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the 20% development fund shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;
