WHEREAS, a letter dated May 29, 2007 of Punong Barangay Jacinto T. Tome, Sr. of Brgy. Bagacay, Tigbauan, Iloilo addressed to the Honorable Sangguniang Bayan Members thru Hon. Vice-Mayor Agaton O.
