RESOLUTION TO RETAIN THE FIREARMS 12 GA SHOTGUN, SQUIBMAN WITH SERIAL NOS. 62665 & 62667 PROCURED BY THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO DURING THE INCUMBENCY OF THE LATE MAYOR EUGENIO TORRENTO

WHEREAS, during the incumbency of the Late Mayor Eugenio Torrento, the Municipality of Tigbauan procured firearms, specifically 12 GA Shotgun, Squibman with Serial Nos. 62665 and 62667;

WHEREAS, the above-mentioned firearms are considered properties of the Municipality of Tigbauan for the use of PNP Personnel assigned at Tigbauan Police Station;

WHEREAS, according to general accounting and auditing rules and regulations, the procuring government agency shall be deemed as owners of any supplies and/or equipments procured by such government agency and shall be deemed responsible for the use and safekeeping of such government properties;

WHEREAS, it is imperative that the above-mentioned firearms be kept and retained by the Municipality of Tigbauan for the use of the personnel of the Tigbauan Police Station;
