RESOLUTION APPROVING THE APPLICATION FOR SUBDIVISION APPROVAL NO. SA-07-07-204 OF REYNALDO TABABA WITH TCT NO. T-81151 LOT NO. 469 WITH AN AREA OF 525 SQUARE METERS MORE OR LESS, CONTAINING FIVE (5) LOTS LOCATED AT BRGY. 9 (POBLACION), TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. SA-07-07-204 located at Brgy. 9 (Poblacion), Tigbauan, Iloilo and its supporting documents of REYNALDO TABABA was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on July 4, 2007 for evaluation;

WHEREAS, after evaluation, the said Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last July 5, 2007 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, TCT No. T-81151 Lot No. 469 with five (5) lots has a total land area of 525 square meters more or less;

WHEREAS, the conditions of said approval shall be the following:

- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.
