**Resolution No. 2007-088**

RESOLUTION ASKING FOR FINANCIAL ASSISTANCE FROM SENATOR RAMON “BONG” REVILLA JR., HOUSE OF SENATE, MANILA, THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) FOR THE REPAIR AND REHABILITATION OF THE TIGBAUAN PUBLIC MARKET, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is a component town of the Province of Iloilo with 52 barangays, having a population of 58,000 more or less and with 37,652 registered voters as of 2007;

WHEREAS, the Municipality of Tigbauan has a rapid expanding population and it badly needs an improved and spacious market for its populace;

WHEREAS, the Tigbauan Public Market was constructed way back in 1950s yet and is now very dilapidated;

WHEREAS, because of limited source of funds, repair and maintenance of the market building and facilities are fast deteriorating resulting to leaking of roofs, torn or broken walls, very poor ventilation and lighting, poor drainage system and inadequate water supply;

WHEREAS, with an improved, presentable and spacious public market, the municipal government can possibly improve its revenue collection and other services by promoting economic growth;

WHEREAS, the Municipal Government of Tigbauan, much to its desire to undertake the major repair and rehabilitation of the Tigbauan Public Market, could not possibly make it unless it can have other sources of funds;

WHEREAS, the municipal officials pin down their hopes on Senator Ramon “Bong” Revilla Jr. for the realization of the project;
