RESOLUTION APPROVING THE APPLICATION FOR CONSTRUCTION OF 42 - METER GUYED TOWER CELL SITE OF BAYAN COMMUNICATIONS, INC. WITH TCT NO. T-15401, LOT NO. 2 WITH AN AREA OF 517 SQUARE METERS MORE OR LESS CONTAINING FIVE (5) LOTS LOCATED AT BRGY. TAN PAEL, TIGBAUAN, ILOILO
