**Resolution No. 2007-104**

RESOLUTION REQUESTING THE BIDS AND AWARDS COMMITTEE TO PROCURE THE PHOTOCOPIER FOR THE USE OF FCDSA COMMITTEE BY ALTERNATIVE METHOD OF PROCUREMENT UNDER SEC. 48 ( b ) AND SEC. 50 of R.A. 9184

WHEREAS, there is an urgent need for the procurement of one photocopier for the use of the First Congressional District Sports Association Committee;

WHEREAS, UBIX Corporation is a manufacturer and dealer of photocopiers known for its quality and good service;

WHEREAS, UNDER Sec. 48 (b) of R.A. 9184 Alternative methods of procurement may be resorted to, in order to promote economy and efficiency, for which direct contracting may be used as an alternative mode of procurement;

WHEREAS, Sec. 48 ( b ) of R.A. 9184 provides “ Direct Contracting, otherwise known as Single Source Procurement – a method of procurement that does not require elaborate bidding documents because the supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale, which offer may be accepted immediately or after some negotiations; “

WHEREAS, Sec. 50 of R.A. 9184 provides “Direct Contracting may be resorted to only in any of the following conditions: x x x ( c ) Those sold by an exclusive dealer or manufacturer, which does not have any sub dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the Government;

WHEREAS, procuring through direct contracting with U-Bix Corporation is a mode of procurement which is most advantageous to the Municipality of Tigbauan, not only in terms of price but also in terms of quality unit and efficient service of the said dealer;
