RESOLUTION CONFORMING AND APPROVING THE SUPPLEMENTAL BUDGET FOR CY 2007 OF BARANGAYS: JAMOG, BUENAVISTA, LANAG, PARARA NORTE, NO.9 (POBLACION), LUBOG, BITAS, BINALIUAN MAYOR, NO. 8 (POBLACION), BAGUMBAYAN, AND DANAQ, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on October 24, 2007 endorsed to this Office the Supplemental Budget No. 001 for CY 2007 of Barangays: Jamog, Buenavista, Lanag, Parara Norte, No.9 (Poblacion), Lubog, Bitas, Binaliuan Mayor, No. 8 (Poblacion), Bagumbayan, and Danao, this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinance embodying the Supplemental Budget No. 001 for CY 2007 of Barangays: Jamog, Buenavista, Lanag, Parara Norte, No.9 (Poblacion), Lubog, Bitas, Binaliuan Mayor, No. 8 (Poblacion), Bagumbayan, and Danao shows apparent compliance with Section 287 of the Local

Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1,2 of 2005 of the DILG and DBM issued on September 30, 2005;
