RESOLUTION REQUESTING FOR FINANCIAL ASSISTANCE IN THE AMOUNT OF TWO MILLION PESOS (P2,000,000) FROM SENATOR FRANCISCO "CHIZ" ESCUDERO FOR THE REPAIR AND IMPROVEMENT OF THE TIGBAUAN COVERED COURT, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is a coastal town of the First District of Iloilo, a 4th class municipality with a population of 57,352 inhabitants (actual survey) as of 2004;

WHEREAS, the Municipality of Tigbauan has a total land area of 8,889 hectares; is composed of 52 barangays and depends mainly on agriculture and fishing as means of the folk's livelihood;

WHEREAS, the municipality's lone covered court is the center and venue of various activities both in the government and private sectors such as programs, cultural presentations, workshops and sports activities;

WHEREAS, the covered court which was constructed 15 years ago is now dilapidated due to erosions causing the roof to leak when it rains, wetting the floor which eventually hampers and making it unsafe for the participants on the various scheduled activities;

WHEREAS, much as the municipal government wanted to rehabilitate and improve the said covered court, it does not have the capability due to financial constraints;

WHEREAS, the repair and improvement of the covered court will greatly be beneficial to the people of Tigbauan;

NOW, THEREFORE, on motion of HON. MARLON TERUÑEZ, Chairman, S.B. Committee on Infrastructure and General Services and was duly seconded by Hon. Suzette Marie Hilado-Banno, Hon.
