RESOLUTION ASKING THE MUNICIPAL MAYOR JAMES EXCELSIOR TORRES TO RELOCATE THE PRESENT FISH SECTION INSIDE THE MAIN PUBLIC MARKET TO THE PUBLIC MARKET ANNEX BESIDE THE MEAT SECTION.

WHEREAS, stalls inside the main public market had been sectioned depending on what kind of commodities the vendors selling wet or dry but mostly dry;

WHEREAS, the fish section being a wet section should be taken out of the main public market since it contribute greatly to the bad odor, wet and messy alleyways;

WHEREAS, it is more advantageous that this section be transferred for reasons of better tax collection, better upkeep of sanitation and reduce theft inside the main market;

WHEREAS, once transferred to the public market annex a curfew could now be in place in the main market since fish vendors usually start their trade at 3:00 o'clock in the morning;

NOW, THEREFORE, on motion of HON. JOSE TAVARRO, JR. Chairman, Committee of Market and Slaughterhouse and duly seconded by Hon. Agaton Tumabotabo and Hon. Loreta Arias,

RESOLVED, to ask the Municipal Mayor James Excelsior Torres To Relocate The Present Fish Section Inside The Main Public Market To The Public Market Annex Beside The Meat Section,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor James Excelsior M. Torres and to all concerned for their information, guidance and/or appropriate action.
