RESOLUTION FOR AUGMENTATION OF FUND FOR THE PAYMENT OF ADDITIONAL BENEFIT/EXTRA CASH GIFT OF THE MUNICIPAL OFFICIALS AND EMPLOYEES, LGU-TIGBAUAN PER LOCAL BUDGET MEMORANDUM NO. 54 DATED DECEMBER 19, 2007 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT.

WHEREAS, Local Budget Memorandum No. 54 dated December 19, 2007 authorized the grant of extra cash gift/additional benefit to officials and employees of LGUs for fiscal year 2007;

WHEREAS, anent thereto, the Municipal Mayor, Honorable James Excelsior M. Torres, thru his 1st Indorsement to the Sangguniang Bayan, had requested for the passing of a resolution for the augmentation of funds for the payment of additional benefits/EXTRA Cash Gift of the municipal officials and employees of the Local Government, this municipality;
