**Resolution No. 2007-130**

RESOLUTION FOR AUGMENTATION OF FUND FOR THE PAYMENT OF ADDITIONAL BENEFIT/EXTRA CASH GIFT OF THE MUNICIPAL OFFICIALS AND EMPLOYEES, LGU-TIGBAUAN PER LOCAL BUDGET MEMORANDUM NO. 54 DATED DECEMBER 19, 2007 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT CHARGEABLE AGAINST THE PS SAVINGS PER SUPPLEMENTAL BUDGET NO.2007-004

WHEREAS, Local Budget Memorandum No. 54 dated December 19, 2007 authorized the grant of extra cash gift/additional benefit to officials and employees of LGUs for fiscal year 2007;

WHEREAS, the Local Government Unit of Tigbauan has unprogrammed surplus savings – CY 2006 in the amount of P2,298,694.00 per certified statement of savings as of CY 2007 duly signed by the *OIC Municipal Accountant* – Mrs. Salvacion T. Trayfalgar and the *OIC Municipal Treasurer* – Mr. Edwin L. Pirote;

WHEREAS, Mrs. Salvacion T. Trayfalgar, OIC-Municipal Accountant has likewise issued a certification that the amount of P1,506,500.00 is available for augmentation of funds for payment of Additional Benefits/Extra Cash Gift of Municipal Officials and Employees of the Local Government Unit of Tigbauan per Local Budget Memorandum No. 54 dated December 19, 2007 of the Department of Budget and Management chargeable against the Personal Services Savings of CY 2007 per Supplemental Budget 2007-004;

WHEREAS, anent thereto, the Municipal Mayor, Honorable James Excelsior M. Torres (*thru his 1<sup>st</sup> Indorsement to the Sangguniang Bayan dated December 27, 2007*), had requested for the urgent passing of the needed resolution for the augmentation of funds for the payment of said additional benefits/EXTRA Cash Gift of municipal officials and employees of this Local Government (*Attached to the said certification is the list of officials and employees reflecting the amount of cash gift*);
