**Resolution No. 2008-005**

RESOLUTION AMENDING SECTION 4 OF INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO.

WHEREAS, the Sangguniang Bayan Internal Rules of Procedure was approved on July 9, 2007;

WHEREAS, Rule XVII of the Internal Rules of Procedure of the Sangguniang Bayan comprises the Enforcement of Orders, Decorum and Disciplinary Action;

WHEREAS, Section 4 of Rule XVII shall be amended to read: "***A member of the Sanggunian who maybe found guilty of disorderly behavior or incurring absences for three (3) consecutive sessions without cause subject to inquiry by the Committee on Good Government, Public Ethics, Accountability and Civil Service shall pay a fine of P500.00 for every unexplained absence;***

***With regard to the SB-of-the-Day, at least one (1) member of the SB must be present as Officer -of-the-Day. In the absence of both SB Members concerned, each one of them shall pay a fine of P100 each.***"
