RESOLUTION APPROVING THE APPLICATION FOR SUBDIVISION APPROVAL NO. SA-01-08-217 OF GLORIA T. GENTELIZO ET-AL WITH TCT NO. T-101,829, LOT NO. 892-E WITH AN AREA OF 3,374 SQUARE METERS MORE OR LESS, CONTAINING TWO (2) LOTS LOCATED AT BRGY. NAMOCON, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. SA-01-08-217 located at Brgy. Namocon, Tigbauan, Iloilo and its supporting documents of GLORIA T. GENTELIZO ET-AL was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on January 29, 2008 for evaluation;

WHEREAS, after evaluation, the said Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last January 29, 2008 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, TCT No. T-101,829, Lot No. 892-E with two (2) lots has a total land area of 3,374 square meters more or less;

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;

WHEREAS, the conditions of said approval shall be the following:

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plan;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.

NOW, THEREFORE, upon motion of Hon. MARLON TERUÑEZ, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Loreta Arias, Hon. Jose Tavarro, Jr., Hon. Norberto Turalba, Hon. Agaton Tumabotabo, Hon. Orville Tangente and Hon. Lea Torrefflores,

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVE, to approve the Subdivision Application No. SA-01-08-217 of GLORIA T. GENTELIZO ET-AL With TCT No. T-101,829, Lot No. 892-E With An Area Of 3,374 Square Meters More Or Less, Containing Two (2) Lots Located At Brgy. Namocan, Tigbauan, Iloilo,
