RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE VILLANUEVA FAMILY REPRESENTED BY CHO CATEQUISTA FOR THE PROPOSED TRANSFER OF MUNICIPAL DUMPSITE FROM BARANGAY SIPITAN TO BARANGAY BANTUD, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the purpose of entering into a Memorandum of Agreement with the Villanueva Family represented by Cho Catequista is the proposed transfer of Municipal Dumpsite from the present site in Barangay Sipitan to Barangay Bantud, Municipality of Tigbauan, Province of Iloilo;

WHEREAS, Barangay Bantud is more accessible to be used as municipal dumpsite;

WHEREAS, there is no existing Memorandum of Agreement between the Municipality of Tigbauan and the landowner of the dumpsite in Barangay Sipitan;
