RESOLUTION AUTHORIZING THE HON. MAYOR JAMES EXCELSIOR M. TORRES TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION (POEA) TO JOIN HANDS AND COORDINATE EFFORTS TO IMPLEMENT AN INTENSIFIED AND WELL SUSTAINED CAMPAIGN AGAINST ILLEGAL RECRUITERS

WHEREAS, the Municipal Government of Iloilo in pursuance to RA 8759 otherwise known as the PESO Act of 1999 will establish the Public Employment Service Office to carry out full employment and equality of employment opportunities for all;

WHEREAS, the problem of illegal recruitment in the country has reached such alarming proportion as to cause serious and general concern;

WHEREAS, foremost among the reasons for the escalation of the problem is the lack or low level of public awareness on the modus operandi of illegal recruiters and the pernicious effects of illegal recruitment;

WHEREAS, while the POEA has launched an Anti-Illegal Recruitment (AIR) Information Campaign, due to its limited resources, it is not in a position to implement on its own a massive and extensive nationwide information campaign that will reach the grassroots level of the public;

WHEREAS, the POEA has launched its Illegal Recruitment Free Local Government Unit (LGU) program campaign that shall enable respective LGUs to participate in the aggressive AIR campaign in their locality;

WHEREAS, the support and assistance of the Local Government of Tigbauan through its Public Employment Services Office (PESO) will greatly contribute to and enhance the success of the AIR program;
