RESOLUTION CONFORMING AND APPROVING THE BARANGAY ANNUAL BUDGET AND 20% BARANGAY DEVELOPMENT PLAN OF BARANGAYS: ALUPIDIAN, NAMOCON, #2 (POBLACION, #3 (POBLACION), BARROC, TAN PAEL, BAYUCO, BUGASONGAN, LINOBAYAN AND JAMOG, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on February 20, 2008 endorsed to this Office the Barangay Annual Budgets and Development Plans for CY 2008 of Barangays: Alupidian, Namoccon, #2 (Poblacion, #3 (Poblacion), Barroc, Tan Pael, Bayuco, Bugasongan, Linobayan and Jamog, this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinance embodying the Annual Budgets and 20% Development Plans for CY 2008 of Barangays: Alupidian, Namoccon, #2 (Poblacion, #3 (Poblacion), Barroc, Tan Pael, Bayuco, Bugasongan, Linobayan and Jamog shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government units;
