**Resolution No. 2008-022**

RESOLUTION AMENDING RESOLUTION 2007-026, THAT THE TOTAL LAND AREA TO BE DONATED TO THE PNP, PRO VI CAMP DELGADO, ILOILO CITY, FOR THE CONSTRUCTION OF THE PNP TIGBAUAN POLICE STATION BUILDING, SHALL BE 298 SQUARE METERS ONLY.

WHEREAS, an endorsement letter from Hon. James Excelsior M. Torres, with an attached revised survey of Municipal Lot proposed to be donated to the Philippine National Police, Tigbauan Police Station was submitted to the Office of the Sangguniang Bayan last January 29, 2008;

WHEREAS, the revised plan decreases the total land area to be donated from previous Four Hundred Nine (409) square meters to Two Hundred Ninety-Eight (298) square meters;

WHEREAS, this resolution repeals one of the provisions in Resolution No. 2007-026, "Resolution Authorizing the Municipal Mayor, Tigbauan, Iloilo to Sign, Execute and Enter in the Deed of Donation and Subdivision Agreement Between the Municipality of Tigbauan, Province of Iloilo and the Philippine National Police, PRO VI, Camp Delgado, Iloilo City, for the Construction of a PNP Building at the Portion of Lot No. 217-A (6190), Iloilo Cadastre, under Tax Declaration 1273-A Containing Three Thousand One Hundred Seven (3,107) square meters more or less";

WHEREAS, stipulated in Resolution 2007-026, the Subdivision Agreement shall be entered for the purpose of dividing Lot 217-A into Two (2) sub-lots, Lot 217-A-2 containing 409 square more or less, where the proposed construction of the new PNP Building will be located;

WHEREAS, upon review of the proposed lot area to be donated, it was found out that there is an existing monument of our national hero, Dr. Jose Rizal on the portion of the lot;

NOW, THEREFORE, on motion of Hon. Marlon R. Teruñez, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Norberto Turalba, Hon. Orville Tangente and Hon. Loreta Arias,

RESOLVED, AS IT IS HEREBY RESOLVE, to pass Resolution Amending Resolution 2007-026, That The Total Land Area To Be Donated To The PNP, PRO VI Camp Delgado, Iloilo City, For The Construction Of The PNP Tigbauan Police Station Building, Shall Be 298 Square Meters Only,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. James Excelsior M. Torres, Municipal Mayor, Tigbauan, Iloilo, PNP PRO VI, Camp Delgado, Iloilo City, and to all concerned agencies for their proper information and guidance.,
