RESOLUTION CONCURRING THE DESIGN FOR THE TRAINING OF THE MUNICIPAL OFFICIALS AND EMPLOYEES ENTITLED: COMPETENCY ENHANCEMENT TRAINING AND INTERFACE WITH THE LOCAL OFFICIALS OF TOP PERFORMING LGUs SCHEDULED ON APRIL 9-14, 2008.

WHEREAS, Rule VIII – Career and Personnel Development of the Omnibus Rules states that every official and employee of the government is an asset or resource to be valued, developed and utilized in the delivery of basic services to the public.
