RESOLUTION CONFORMING AND APPROVING THE BARANGAY ANNUAL BUDGET AND 20% DEVELOPMENT PLAN OF BARANGAYS: DORONG-AN, BANTUD, NO. 5 (POBLACION), CANABUAN, SERMON AND NO. 4 (POBLACION), MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on March 12, 2008 endorsed to this Office the Barangay Annual Budgets and Development Plans for CY 2008 of Barangays: Dorong-an, Bantud, No.5 (Poblacion), Canabuan, Sermon and No. 4 (Poblacion), this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinance embodying the Annual Budgets and 20% Development Plans for CY 2008 of Barangays: Dorong-an, Bantud, No.5 (Poblacion), Canabuan, Sermon and No. 4 (Poblacion) shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;
