Resolution No. 2008-030

RESOLUTION REQUESTING FOR THE URGENT RELEASE OF FUNDS FOR SUBSIDY TO THE REGIONAL TRIAL COURT BRANCH 67 IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) FOR THE ACQUISITION OF ONE COMPUTER UNIT AND AUTHORIZING THE MUNICIPAL VICE MAYOR TO COUNTERSIGN THE CHECK FOR THE ISSUANCE THEREOF

WHEREAS, sometime on July 3, 2006 the Regional Trial Court Branch 67 requested for the financial assistance to be used for the acquisition of computer unit which is necessary for the delivery of public service and prompt disposition of cases pending before said office;

WHEREAS, Regional Trial Court Branch 67 covers the area of the Municipality of Tigbauan and has jurisdiction on cases whether civil or criminal, within the territorial jurisdiction of the Municipality of Tigbauan;

WHEREAS, the Office of the Sangguniang Bayan has available funds for the release of the subsidy for the Regional Trial Court Branch 67 which is chargeable against continuing appropriation under the Office of the Sangguniang Bayan;

WHEREAS, the Municipal Budget Officer has already certified as to the existence of available appropriation and the Municipal Accountant has already certified that allotment was obligated for the purpose indicated and supporting documents complete for the subsidy for the Regional Trial Court Branch 67;

WHEREAS, the voucher for the said subsidy was forwarded and received by the Office of the Municipal Treasurer on March 3, 2008 but until this date, no action was made by the said Office;

WHEREAS, since the funds for the subsidy to the Regional Trial Court Branch 67 shall be taken from the budget of the Sangguniang Bayan, the Municipal Vice Mayor is authorized to sign on the check issued for the payment thereof;

NOW THEREFORE, upon motion of Hon. Suzette Tenefrancia-Alquisada, Chairman, Committee on Peace and Order, Public Safety, Women, Family, Human Rights and Legal Matters and duly seconded by Hon. Suzette Marie Hilado-Banno, Hon. Agaton Tumabotabo, Hon. Marlon Teruñez, Hon. Norberto Turalba, Hon. Loreta Arias, Hon. Elmer Torrato, Hon. Orvillo Tangente and Hon. Lea Torretores,

RESOLVED, to request for the Urgent Release Of Funds For Subsidy To The Regional Trial Court Branch 67 In The Amount Of Forty Thousand Pesos (P40,000.00) For The Acquisition Of One Computer Unit And Authorizing The Municipal Vice Mayor To Countersign The Check For The Issuance Thereof,
