RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. NASSER C. PANGANDAMAN, SECRETARY OF THE DEPARTMENT OF AGRARIAN REFORM (DAR) IN THE AMOUNT OF FOUR MILLION FIVE HUNDRED THOUSAND PESOS (P4,500,000.00) FOR THE IMPROVEMENT OF FARM-TO-MARKET ROADS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is an agricultural municipality;

WHEREAS, twenty five percent (25%) of its agricultural area is irrigated rice land but most of it is devoted to upland agriculture conducive to high value crops;

WHEREAS, the farm-to-market road is necessary in order to bring the produced crops to the market in a more accessible way;

WHEREAS, the following barangays need an improved farm-to-market road, to wit:
