RESOLUTION REQUESTING THE NATIONAL DISASTER AND COORDINATING COUNCIL (NDCC) AND BICOL CARE COMMISSION THROUGH EXECUTIVE DIRECTOR, DR. ANTHONY GOLEZ, TO ALLOCATE SIX MILLION THREE HUNDRED SIXTY FIVE THOUSAND PESOS (P6,365,000.00) FOR THE REHABILITATION OF FARM-TO-MARKET ROADS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is an agricultural municipality;

WHEREAS, twenty five percent (25%) of its agricultural area is irrigated rice land but most of it is devoted to upland agriculture conducive to high value crops;

WHEREAS, the farm-to-market road is necessary in order to bring the produced crops to the market in a more accessible way;

WHEREAS, the following barangays need an improved farm-to-market road, to wit:

NAPNAPAN NORTE-LINO FLORES	-	P2,240,000
BUYU-AN-BUGASONGAN	-	P4,125,000

WHEREAS, the realization of these farm-to-market roads could be achieved through the benevolent help of the National Disaster and Coordinating Council (NDCC);

WHEREAS, the Local Government Unit of the Municipality of Tigbauan will implement the said project;

ANTHONY GOLEZ, to allocate The Amount Of Six Million Three Hundred Sixty Five Thousand Pesos (P6,365,000.00) For The Rehabilitation Of Farm-To-Market Roads In The Municipality Of Tigbauan, Province Of Iloilo,
