Resolution No. 2008-048

RESOLUTION CREATING BAGACAY HIGH SCHOOL AS AN EXTENSION SECONDARY SCHOOL LEVEL OF TIGBAUAN NATIONAL HIGH SCHOOL MAIN CAMPUS, TIGBAUAN, ILOILO

WHEREAS, the PTA Board of Bagacay Elementary School, PTA Board of Danao Elementary School and the Barangay Councils of Bagacay, Cansilayan, Supa, Bugasongan, Danao and Guisian conducted their joint meeting last August 1, 2007 and passed a “Resolution Earnestly Appealing to the Office of the Regional Director, Department of Education, Region VI, Office of the School Division Superintendent, Division of Iloilo, Office of the Governor, Province of Iloilo, Office of the Municipal Mayor and Sangguniang Bayan Members, Municipality of Tigbauan, Office of the District Supervisor, District of Tigbauan, For Their Assistance to Start and Support the Establishment of a Secondary School Level at barangay Bagacay, Tigbauan, Iloilo”;

WHEREAS, copy of said resolution was forwarded to Hon. Mayor James Excelsior Torres and the latter indorsed the same on Sept. 26, 2007 to the Office of the Sangguniang Bayan, this municipality for the Body’s appropriate action, however, the SB thru the Committee on Education laid such matter on the table for the reason that there is a need for the submission of other requirements for the creation of a Barangay High School;

WHEREAS, on May 10, 2008, the P.T.A. Board of the six (6) concerned Barangays came up with the new resolution – Joint Resolution No. 07 Series of 2008, “Resolution Earnestly Requesting Hon. James Excelsior M. Torres, Municipal Mayor and Chairman of the Local School Board, Municipality of Tigbauan, To Recommend To The Hon. Members of the Sangguniang Bayan Through, Hon. Suzette Marie Hilado

Banno, Chaimran, Committee on Education, for the Creation of an Extension of a Secondary School Level at Barangay Bagacay, Tigbauan, Iloilo” (Attached as ANNEX “A” is a copy of the said Resolution which is self-explanatory and forming as an integral part of this Resolution);

WHEREAS, on May 14, 2008 S.B. Session, the Hon. Mayor James Excelsior M. Torres again endorsed said Joint Resolution NO. 07, Series of 2008 to the Sanggunian and the Hon. Presiding Officer referred the same to the SB Committee on Education Chaired by Hon. Suzette Marie Hilado-Banno for study and recommendation;

WHEREAS, during the S.B. Regular session on June 11, 2008, the S.B. Committee on Education, Health and Sanitation rendered a committee report (Committee Report No. 2008-039, attached as ANNEX “B” and likewise form as an integral part of this resolution) and the August Body adopted the committee’s recommendation to pass this new resolution, “Resolution Creating Bagacay High School As An Extension Secondary School Level of Tigbauan National High School Main Campus, Tigbauan, Iloilo”;

WHEREAS, pursuant to Section 100 ( c ) par. 2 and Article 184 (f) par. 2 of the Local Government Code of 1991 (RA 7160), the Annual Local School Board Budget shall give priority to the establishment and maintenance of extension classes of public elementary and secondary schools when necessary;

NOW, THEREFORE, on motion of HON. SUZETTE MARIE HILADO-BANNO, Chairperson, S.B. Committee on Education, Health and Sanitation and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Marlon Teruñez, Hon. Norberto Turalba, Hon. Loreta Arias, Hon. Elmer Torrato and Hon. Orvillo Tangente,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to Create Bagacay High School As an Extension Secondary School Level Of Tigbauan National High School main Campus, Tigbauan, Iloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor James Excelsior M. Torres, and to all concerned for their proper information and/or appropriate action
