RESOLUTION CONFORMING AND APPROVING THE BARANGAY ANNUAL BUDGET AND 20% BARANGAY DEVELOPMENT PLAN OF BARANGAYS SIPITAN AND BINALIUAN MENOR, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on May 20, 2008 endorsed to this Office the Barangay Annual Budget and Development Plan for CY 2008 of Barangays Sipitan and Binaliuhan Menor, this municipality;

WHEREAS, the Review of the foregoing appropriation Ordinance embodying the Annual Budget and 20% Development Plan for CY 2008 of Barangays Sipitan and Binaliuhan Menor shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the 20% development fund shall be in accordance with Section 287 of the Local Government Code Rule XXXVI. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo, dated 9 March 2001 Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government units;

Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Marlon Teruñez, Hon. Norberto Turalba, Hon. Loreta Arias, Hon. Elmer Torrato and Hon. Orvillo Tangente,
