RESOLUTION URGENTLY DECLARING THE MUNICIPALITY OF TIGBAUAN AS UNDER A STATE OF CALAMITY DUE TO TYPHOON FRANK AND AUTHORIZING THE RELEASE OF THE AMOUNT OF ONE MILLION (1M) PESOS FROM 5% CALAMITY FUND OF THE 2008 ANNUAL BUDGET OF THE MUNICIPALITY OF TIGBAUAN

WHEREAS, Typhoon Frank intensely brought heavy rainfall and flash floods, resulting to tremendous damages to the lives and properties of the people, this municipality;

WHEREAS, due to serious and rampaging inundation brought about by typhoon Frank, fifteen (15) persons were already reported dead, five (5) missing as well as widespread, all-pervasive, and serious damages to houses, large cattle, livestock, fowl, and growing plants and crops such as palay;

WHEREAS, inland barangays are not the only places adversely affected, but also the barangays along the shorelines and riverbanks which have been battered by strong waves aggravated by rising tides and strong current from the Sibalom River;

WHEREAS, the complete extent of losses and/or damages could not be immediately ascertained and assessed, as incoming reports arrive gradually because some barangays are still isolated due to the destruction of Hanging Bridges and barangay roads;

WHEREAS, "...In case of calamity and upon the recommendation of the Local Chief Executive, the Sanggunian concerned shall immediately convene within 24 hours from the occurrence of the calamity and pass a Resolution declaring the area as under a state of calamity. The Sanggunian concerned may also adopt measures to protect

the lives and properties in the area and implement disaster mitigation measures". (Section 6 (a), Rules and Regulations Implementing Republic Act No. 8185 "An Act Amending Section 324 (d) R.A. No. 7160, otherwise known as the Local Government Code of 1991".);

WHEREAS, to provide relief assistance to the affected barangays and victims of the calamity brought about by typhoon Frank, it is necessary to release the amount of One Million Pesos (P1,000,000.00) from the 5% Calamity Fund of the 2008 Budget of the Municipality of Tigbauan;

WHEREAS, the Barangays of this Municipality which are affected by the calamity are also authorized to release at least 50% of their 5% Calamity Fund from their respective Barangay Budgets to cover expenses for relief operations and rehabilitation in relation to the calamity brought about by typhoon Frank;

NOW THEREFORE, upon motion of Hon. Suzette Marie Hilado-Banno, Chairperson, S.B. Committee on Appropriation, Budget, Finance, Accounts and Ways & Means and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Marlon Teruñez, Hon. Norberto Turalba, Hon. Loreta Lungay-Arias and Hon. Orvillo Tangente,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to Urgently Declare The Municipality Of Tigbauan As Under A State Of Calamity Due To Typhoon Frank And Authorizing The Release Of The Amount Of One Million (1M) Pesos from the 5% Calamity Fund of the 2008 Annual Budget of the Municipality of Tigbauan.

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Hon. James Excelsior M. Torres, the Department Heads, the PNP, the Liga ng mga Barangay c/o Hon. Orvillo Tangente, the Sangguniang Kabataan c/o Hon. Lea Torreflores and to concerned humanitarian persons/agencies, for their information and appropriate action.
