Resolution No. 2008-052

“RESOLUTION REQUESTING THE MUNICIPAL BUDGET OFFICER, OIC MUNICIPAL ACCOUNTANT AND OIC MUNICIPAL TREASURER TO LOOK FOR OTHER SOURCES OF FUNDS AND/OR SURPLUS SAVINGS TO SUPPLEMENT THE REPAIR/REHABILITATION OF INFRASTRUCTURE AND OTHER GOVERNMENT FACILITIES WHICH WERE DAMAGED CAUSED BY THE RECENT TYPHOON FRANK”

WHEREAS, last June 20 to 22, 2008, the Municipality of Tigbauan was ravaged by Typhoon “FRANK” which caused tremendous damage to the lives and properties of the people of this municipality;

WHEREAS, a portion of the 5% Calamity Fund for 2008 in the amount of One Million Pesos (P1,000,000.00) was already released to cover expenses for relief operations and rehabilitation in relation to the calamity brought about by typhoon “Frank”;

WHEREAS, infrastructure and other government facilities such as hanging bridges, municipal and barangay roads and bridges, health centers, and other government structures were damaged by typhoon “Frank” to which the amount appropriated for 2008 5% calamity fund is not enough to rehabilitate the said structures;

WHEREAS, in order to provide continuous effective and efficient basic services and facilities to the constituents of this municipality, additional funds is needed for the repair/rehabilitation of the infrastructure and other government facilities which were damaged by the recent typhoon “Frank”;

NOW, THEREFORE, on motion of HON. SUZETTE TENEFRANCIA-ALQUISADA, and duly seconded by Hon. Suzette Marie Hilado-Banno, Hon. Agaton Tumabotabo, Hon. Marlon R. Teruñez, Hon. Norberto Turalba, Hon. Orvillo Tangente and Hon. Lea Torreflores,

RESOLVED, to Request The Municipal Budget Officer, OIC Municipal Accountant and OIC Municipal Treasurer To Look For Other Sources Of Funds And/Or Surplus/Savings To Supplement The Repair/.Rehabilitation Of Infrastructure And Other Government Facilities Which Were Damaged Caused By The Recent Typhoon “Frank”,

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Mayor, James Excelsior M. Torres to Municipal Budget Officer, to OIC Municipal Accountant, to OIC Municipal Treasurer and to all concerned for their information and appropriate action.
