RESOLUTION CONFORMING AND APPROVING THE BARANGAY ANNUAL BUDGET AND 20% BARANGAY DEVELOPMENT PLAN OF BARANGAYS: PARARA SUR AND ATABAYAN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on June 3, 2008 endorsed to this Office the Barangay Annual Budget and Development Plan for CY 2008 of Barangays: Parara Sur and Atabayan, this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinance embodying the Annual Budget and 20% Development Plan for CY 2008 of Barangays: Parara Sur and Atabayan shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;
