**Resolution No. 2008-056**

RESOLUTION COMMENDING THE RESCUERS WHO RISKED THEIR LIVES FOR THEIR VALIANT EFFORTS DURING THE RESCUE AND RETRIEVAL OF THE TYPHOON VICTIMS LAST JUNE 21 TO 23, 2008

WHEREAS, last June 20 to 22, 2008, the Municipality of Tigbauan was ravaged by typhoon “Frank” which resulted to tremendous damage to the lives and properties of the people of this municipality;

WHEREAS, during the said calamity, Members of the Bureau of Fire Protection, Philippine National Police, Tigbauan Station, 606<sup>th</sup> Provincial Mobile Group and other civilian volunteers risked their lives to rescue and retrieve the typhoon victims in the affected barangays of this municipality;

WHEREAS, because of their valiant efforts, hundreds of people were saved by the rescuers and thereby reducing the casualties of typhoon “Frank”;

WHEREAS, we, who represent the people of Tigbauan, would like to express and relay appreciation and commend the following for their valiant efforts in the rescue and retrieval operation last June 21 to 23, 2008:
