RESOLUTION CONFORMING AND APPROVING THE BARANGAY SUPPLEMENTAL BUDGET NO.1 EMBODYING APPROPRIATION ORDINANCE NO. 1, BOTH SERIES OF 2008 OF BARANGAYS: NAPNAPAN NORTE AND BAGUMBAYAN, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipal Budget Officer on July 2, 2008 endorsed to this Office the Barangay Supplemental Budget No.1 Embodying Appropriation Ordinance No. 1, Both Series Of 2008 Of Barangays: Napnapan Norte and Bagumbayan, this municipality;

WHEREAS, the Review of the foregoing Appropriation Ordinance embodying the Supplemental Budget for CY 2008 of Barangays: Napnapan Norte and Bagumbayan shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, the appropriation for the 20% Development Fund shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the 20% development fund shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 Joint Memorandum Circular No. 1 of 2005 of the DILG and DBM issued on September 30, 2005;

WHEREAS, compliance with all existing laws, rules, and regulations shall be the sole responsibility of the officials of the implementing local government units;

Elmer Torrato and Hon. Lea Torreflores,
