RESOLUTION URGENTLY REQUESTING THE LEAGUE OF MUNICIPALITIES, PHILIPPINE COUNCILORS' LEAGUE, THE VICE MAYORS' LEAGUE, THE MAYORS' LEAGUE, THE GOVERNORS' LEAGUE OF THE PHILIPPINES, LGUs AND OTHER CONCERNED GOVERNMENT OFFICES/AGENCIES OF THE REPUBLIC OF THE PHILIPPINES TO FAVORABLY INDORSE AND/OR PASS A SIMILAR HEREINATTACHED RESOLUTION, "RESOLUTION EARNESTLY APPEALING TO HER EXCELLENCY PRESIDENT GLORIA MACAPAGAL ARROYO TO TAKE IMMEDIATE ACTION ON THE PROBLEMS OF GOVERNMENT EMPLOYEES, RETIREES AND PENSIONERS THROUGHOUT THE COUNTRY, WITH THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) REGARDING THEIR UNRECORDED AND/OR IMPROPER RECORDING OF REMITTANCES AND LOAN PAYMENTS RESULTING TO UNJUST/QUESTIONABLE INTERESTS AND SURCHARGES, AND TO REPLACE THE GSIS PRESIDENT AND GENERAL MANAGER, MR. WINSTON GARICA"

WHEREAS, it is of public knowledge that the GSIS is practically covered with scandals and mismanagement, resulting to inefficiencies in services and demoralization of its members;

WHEREAS, we know for a fact that the members are the life-blood and the soul of GSIS, thus they deserve all the services they needed, from loan applications to availment of pensions and other benefits;

WHEREAS, it has been proven by a myriad of complaints and controversies aired in the media, court litigations, and personal testimonies of discontented members;

WHEREAS, all these defeat the purpose for the creation and existence of GSIS, and the cause of this is the mismanagement of Mr. Winston Garcia;

WHEREAS, we are GSIS members who have been deprived or could be deprived of the services due on us, but most of all, we are representatives of our people, who expect protection and steadfast representation for their welfare;

WHEREAS, the members of this August Body therefore appeal to our fellow Councilors, political leaders, heads of the different LGUs, government agencies and fellow GSIS members, to act similarly by passing a resolution herein suggested and attached, as passed by this Sanggunian Resolution No. 2008-065;

NOW, THEREFORE, on motion of Hon. Marlon R. Teruñez and duly seconded by Hon. Agaton O. Tumabotabo, Hon. Norberto T. Turalba, Hon. Loreta L. Arias, Hon. Elmer T. Torrato and Hon. Lea E. Torreflores,

RESOLVED, to urgently Request The league Of Municipalities, Philippines Councilors' League, The Vie Mayors' League, The Mayors League, The Governors' League Of The Philippines, Lgus And Other Concerned Government Offices/Agencies Of The Republic Of The Philippines To Favorably Indorse And/Or Pass A Similar Hereinattached Resolution, "Resolution Earnestly Appealing To Her Excellency President Gloria Macapagal Arroyo To Take Immediate Action On The Problems Of Government Employees, Retirees And Pensioners Throughout The Country, With The Government Service Insurance System (GSIS) Regarding Their Unrecorded And/Or Improper Recording Of Remittances And Loan Payments Resulting To Unjust/Questionable Interests And Surcharges, And To Replace The GSIS President And General Manager, Mr. Winston Garcia"

RESOLVED FURTHER, to furnish copies of this resolution to the aforementioned leagues thru their respective presidents and other concerned government offices/agencies/instrumentalities for their appropriate action, support and/or favorable indorsement,
