**Resolution No. 2008-070**

RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. PROSPERO C. NOGRALES, SPEAKER, HOUSE OF REPRESENTATIVES, REPUBLIC OF THE PHILIPPINES IN THE AMOUNT OF TWENTY MILLION PESOS (P20,000,000.00) FOR THE REPAIR AND MAINTENANCE OF INFRASTRUCTURE PROJECTS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, last June 20 to 22, 2008, the Municipality of Tigbauan was ravaged by typhoon “FRANK” which caused tremendous damage to the lives and properties of the people of this municipality;

WHEREAS, infrastructure and other government facilities such as hanging bridges, municipal and barangay roads and bridges, health centers, and other government structures were damaged by typhoon “Frank” to which the amount appropriated for 2008 5% calamity fund is not enough to rehabilitate the said structures;

WHEREAS, in order to provide continuous, effective and efficient basic services and facilities to the constituents of this municipality, additional funds are needed for the repair/rehabilitation of the infrastructure and other government facilities which were damaged by the recent typhoon “Frank”;

WHEREAS, there is an urgent need to provide fund to LGUs in order to repair and/or maintain such infrastructure projects damaged by said calamity;

WHEREAS, Hon. Prospero Nograles, being a Tigbaueño by blood, the people of Tigbauan look up to him and are asking for his assistance to help rehabilitate the infrastructures and facilities which were damaged by Typhoon “Frank”;

NOW, THEREFORE on motion HON.VICE MAYOR ROEL T. JARINA, and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Marlon Teruñez, Hon. Loreta Arias, Hon. Elmer Torrato and Hon. Lea Torreflores,

RESOLVED, to Request Financial Assistance From HON. PROSPERO C. NOGRALES, Speaker, House Of Representatives, Republic Of The Philippines In The Amount Of Twenty Million Pesos (P20,000,000.00) For The Repair And Maintenance Of Infrastructure Projects In The Municipality Of Tigbauan, Province Of Iloilo,
