**Resolution No. 2008-080**

RESOLUTION CONFIRMING THE CREATION OF THE GENERAL SERVICES OFFICE IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Rule XVIII of R.A. 7160 ( Article 115 – 123) provides the different Appointive Local Officials of the province, city, municipal, and barangay; states the qualifications, powers and duties of the appointive local officials; and the mode of resignations;

WHEREAS, the position of general services officer is included in the list of appointive local officials. Article 122, letter t: (of R.A. 7160) indicates the functions and duties of the aforesaid position;

WHEREAS, at present the Municipality of Tigbauan has no General Services Office/Officer;

WHEREAS, the creation of the general services office could assist the LGU in extending its valuable public services for the municipality;

WHEREAS, the General Services Office shall be staffed by permanent employee/s in a designated capacity without any additional compensation;

NOW, THEREFORE, upon motion of Hon. MARLON R. TERUÑEZ, Chairman, Committee on Infrastructure and General Services and duly seconded by Hon. Suzette Marie Hilado-Banno, Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon. Norberto Turalba, Hon. Jose Tavarro, Jr., Hon. Loreta Lungay-Arias, and Hon. Lea Torreflores,

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVE, to confirm the Creation of the General Services Office in the Municipality of Tigbauan, Province of Iloilo;

RESOLVED FURTHER, that the creation of the General Services Office shall not include the creation of personnel thereat;

RESOLVED FINALLY, to forward copies of this resolution to the Office of the Municipal Mayor, Tigbauan, Iloilo for his information and appropriate action.
