Resolution No. 2008-082

RESOLUTION APPROVING THE APPLICATION FOR SUBDIVISION APPROVAL NO. SA-07-08-224 OF MICHAEL ANGULO ET-AL WITH TCT NO. T-18138, LOT NO. 1624-D WITH A TOTAL AREA OF 1,736 SQUARE METERS MORE OR LESS, CONTAINING TWO (2) LOTS LOCATED AT BRGY. BAGUMBAYAN, TIGBAUAN, ILOILO

WHEREAS, the Subdivision Application No. SA-07-08-224 located at Brgy. Bagumbayan, Tigbauan, Iloilo and its supporting documents of MICHAEL ANGULO ET-AL was submitted to the Office of the Evaluation Officer, Tigbauan, Iloilo on July 30, 2008 for evaluation;

WHEREAS, after evaluation, the said Subdivision Application and its supporting documents were forwarded to the Office of the Sangguniang Bayan last July 30, 2008 by the Evaluating Officer for authorization and approval;

WHEREAS, the said application, TCT No. T-18138 Lot No. 1624-D with Two (2) lots has a total land area of 1,736 square meters more or less;

WHEREAS, the purpose/intent of this application is to sell;

WHEREAS, the conditions of said approval shall be the following:

- a.) In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- b.) Comply with all the corrections as indicated on the plan;
- c.) Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- d.) This approval does not exempt the proponent from pertinent requirements of other government agencies;
- e.) This approval does not exempt the proponent from securing registration and license to sell from HLURB.

BE IT RESOLVED, AS THIS SANGGUNIANG BAYAN HEREBY RESOLVE, to approve the Subdivision Application No. SA-07-08-224 Of MICHAEL ANGULO ET-AL With TCT No. T-18138, Lot No. 1624-D With An Area Of 1,736 Square Meters More Or Less, Containing Two (2) Lots Located At Brgy. Bagumbayan, Tigbauan, Iloilo,
