**Resolution No. 2008-095**

RESOLUTION AUTHORIZING THE TRANSFER OF THE SCATTERED STATUES OF OUR HEROES – FR. JOSE BURGOS, GENERAL FERMIN RIVAS, AND PRESIDENT RAMON MAGSAYSAY, FROM THEIR PRESENT SITES TO THE PROPOSED HEROES’ CORNER AT THE CENTENNIAL ARCH IN FRONT OF THE MUNICIPAL BUILDING

WHEREAS, there is a laudable proposal to transfer the statues of our heroes – Fr. Jose Burgos, General Fermin Rivas, and President Ramon Magsaysay, from their present locations to a proposed HEROES CORNER at the Centennial Arch in front of the Municipal Hall;

WHEREAS, with the statues of our heroes to be concentrated in one area at the proposed HEROES’ CORNER, the act of giving them appropriate honors and floral offerings, during the annual celebrations of our Heroes Day, will be easily facilitated and fulfilled;

WHEREAS, due to its historical landmarks and significant attractions, Tigbauan has been recommended to tourists, and to students on their field trips by the Department of Tourism Region 6, as a “. . . first stop on the national road to Antique. . . “;

WHEREAS, with its concentration in one area, and its easy accessibility, our HEROES’ CORNER could give added historical significance and luster to our town plaza;

WHEREAS, there is no existing law or regulation to prevent this LGU from transferring these statues from their present location in our plaza to our proposed ***HEROES’ CORNER***, ***EXCEPT*** if the statues stand on the sites where the heroes were actually born, or where the

heroes actually died, because these sites are intimately connected and significant to their heroism;

NOW, THEREFORE, on motion of Hon. Agaton O. Tumabotabo, Chairman, SB Committee on Tourism, History, and Cultural Affairs and duly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Norberto Turalba, Hon. Jose Tavarro, Jr., Hon. Loreta Arias, Hon. Elmer Torrato and Hon. Lea Torreflores, Be It

RESOLVED, as we do hereby resolve, To Authorize The Transfer Of The Scattered Statues Of Our Heroes – Fr. Jose Burgos, General Fermin Rivas, And President Ramon Magsaysay, From Their Present Sites To The Proposed HEROES’ CORNER At The Centennial Arch In Front Of The Municipal Building;

RESOLVED FURTHER, to provide copies of this Resolution to the National Historical Commission, to the Office of the Hon. Municipal Mayor, and to all Department Heads for their information, appropriate action, and guidance.
