Resolution No. 2008-099

RESOLUTION AUTHORIZING HON. JAMES EXCELSIOR M. TORRES, MUNICIPAL MAYOR, TIGBAUAN, ILOILO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FILED OFFICE VI, THRU THE REGIONAL DIRECTOR, TERESITA S. ROSALES, IN CONNECTION WITH THE IMPLEMENTATION OF EMERGENCY SHELTER ASSISTANCE (ESA) TO THE DISPLACED FAMILIES AS A RESULT OF TYPHOON “FRANK”

WHEREAS, on June 20 to 21, 2008, Typhoon “Frank” hit the Western Visayas Region leaving hundreds of people dead and thousands homeless, thus a need for permanent relocation of residents from affected areas;

WHEREAS, the DSWD is mandated to implement programs and projects that will help the disaster victims recover and restore social functioning of the community;

WHEREAS, the Provincial/City/Municipality is mandated under the Local Government Code of the Philippines to deliver basic. Regular and direct services to its constituents;

WHEREAS, the DSWD and the Municipality of Tigbauan agreed to jointly implement in coordination with other government and private entities for the provision of emergency shelter assistance in the amount of P5,000 to P10,000 to the displaced families for the repair of their totally damaged houses;

WHEREAS, for and in consideration of the foregoing premises and covenants and subject to terms and conditions hereinafter set forth, the DSWD and the Municipality of Tigbauan by these present, do hereby bind themselves to AGREE and ADOPT this Memorandum of Agreement (MO) on the following terms and conditions:

- a. The DSWD shall:
  1. Ensure that identified priority family beneficiaries are validated in coordination with the Local Government Unit;
  2. Provide funding assistance for local shelter units and emergency shelter assistance (ESA) equivalent to the number of units per approved project proposal direct to identified beneficiaries;
  3. Conduct regular monitoring coordination and consultation with the LGU regarding the implementation of the program;
  4. Provide technical assistance to the LGUs in the implementation of shelter assistance/ESA; and
  5. Shall provide prescribed stickers to all constructed/repaired/reconstructed houses for easy identification and monitoring by both DSWD, LGUs and other public.
- b. The Municipality of Tigbauan shall:
  1. Ensure completion of all ESA units within the agreed period. Failure to comply with this agreement, the Local Government Unit will fully assume responsibility for the completion of the unfinished units not later than six (6) months from project start;
  2. Ensure that the clients are able to manage properly the ESA that will be directly released to them. The LGU should create a committee to assist in the encashment, procurement of housing materials in the actual construction to protect the beneficiaries from exploitation, opportunism and other negative influence and liquidation;
  3. Ensure provision of beneficiary access to basic services such as water, electricity and sanitation for those families which shall be relocated;
  4. Organize the beneficiaries into neighborhood shelter association (NASA) to facilitate their involvement in the *construction*. repair of their houses;
  5. Submit an accomplishment report on the status of project using the attached prescribed format of the DSWD.
