WHEREAS, the Review of the foregoing Appropriation Ordinances embodying the Supplemental Budgets for CY 2008 of Barangays: Barosong, Barroc, Bayuco, Nagba, Parara Sur, Binaliuan Menor, Danao, Sermon, Sipitan, San Rafael, #4 (Poblacion), Taro, Napnapan Norte, Guisian, Isian, Atabayan, Cordova Sur, Bangkal, #9 (Poblacion), #7 (Poblacion), Canabuan, #6 (Poblacion), and Tan Pael, shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, and Executive Order No. 9 of President Gloria Macapagal Arroyo dated 9 March 2001 and Joint Memorandum Circular No. 1, Series of 2005 of the DILG and DBM issued on September 30, 2005;
