RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO AND SIGN FOR AND BEHALF OF THE MUNICIPALITY OF TIGBAUAN THE MEMORANDUM OF AGREEMENT WITH THE NATIONAL DAIRY AUTHORITY AND THE ILOILO FEDERATION OF DAIRY AUTHORITY AND THE ILOILO FEDERATION OF DAIRY COOPERATIVES (IFEDCO) FOR THE IMPLEMENTATION OF THE COMMUNITY MILK FEEDING PROGRAM IN THE MUNICIPALITY

WHEREAS, submitted for the consideration and proper action of the Body is the letter-request of the Municipal Mayor dated December 10, 2008 for authority to enter into and sign a Memorandum of Agreement with the National Dairy Authority and IFEDCO for the implementation of the Community Milk Feeding Program in this municipality;

WHEREAS, the program, which is being continuously implemented in this municipality, aims to eradicate malnutrition among pre-school children by giving them pasteurized and homogenized fresh milk through the rural health units;

WHEREAS, the program will benefit one hundred thirty five (135) pre-school children identified by the rural health units to be malnourished for a period of one hundred twenty (120) feeding days;

WHEREAS, the municipality and the National Dairy Authority will share the One Hundred Forty Five Thousand Eight Hundred Pesos (Php145,800.00) cost of the fresh milk needed on a forty-sixty counterpart basis;

NOW, THEREFORE, the August Body, on motion of Hon. Suzette Marie Hilado-Banno, Chairman, S.B. Committee on jointly seconded by Hon. Suzette Tenefrancia-Alquisada, Hon. Agaton Tumabotabo, Hon.
